Dinking has responsibility to send the spare parts to SVEAM for replacement if the failures are due to defect in materials or workmanship by the factory.

**ARTICLE 7 : SHIPPING DOCUMENTS**

One copy set of shipping documents (Commercial Invoice, detailed packing list, Bill of Lading, Certificate of Origin Form E) must be sent to the buyer directly within 7 days after shipment date.

**ARTICLE 8: GENERAL CONDITIONS**

Both parties undertake to fulfill absolutely and strictly this contract accordance with INCOTERMS 2000 revision. Any changes and amendments of this contract shall be made in writing and subject to mutual agreement.

All disputes arising out of or in relation to this contract, which both parties can not reach an amicable agreement, shall be finally settled by the Vietnam International Arbitration Centre (VIAC) at the Chamber of commerce and Industry of Vietnam in accordance with its Arbitration Rules. Arbitration fees and other related charges shall be born by the losing party unless otherwise agreed.
